Aloha e nā Mākua,

Ho'omaika'i! E komo mai i Nā Kula 'o Kamehameha. This letter is to inform you of the required steps for your child to get medically cleared to attend school.

All medical clearance is done through our Mo'omō'ali Olakino Electronic Health Record (EHR) Parent Portal. You will receive a separate email to set up your KS Account to access the EHR Parent Portal via <u>https://ohana.ksbe.edu</u>. All documentation should be uploaded to the EHR Parent Portal as a PDF document or JPG image. Please complete all requirements by June 1, 2025.

HEALTH SUMMARY

Enter your child's allergies, medications, medical conditions, hospitalizations, and surgeries/procedures. If there are any changes during the school year, please update the information.

TUBERCULOSIS CLEARANCE

Complete a tuberculosis risk assessment (TB Screen). If the TB Screen is positive, your child will be required to obtain TB clearance from their regular healthcare provider.

PHYSICAL EVALUATION

Upload a completed KS Physical Evaluation form for your child based on a physical examination that was done on or after July 1, 2024. Ensure your child's healthcare provider has completed the form in its entirety and signed the form. Please do not upload the health history checklist on page 1.

To participate in a sport, student-athletes must complete a physical examination every 13 months (12 months, with a one-month grace period).

IMMUNIZATIONS

The Hawai'i Department of Health requires that students receive certain immunizations to enter school. Upload an immunization record that shows your child received these immunizations.

*Two doses are required if <age 15 years at initial vaccination; three doses if age 15 years or older.

**An additional dose of MCV administered after age 16 years is required if the student is entering as an 11th or 12th grade student.

REQUEST FOR ADMINISTRATION OF MEDICATION

If your child will need to take or have available a medication on campus that you would like for KS Health Services staff or their designee to administer, a completed Request for Administration of Medication (RAM) form signed by your child's healthcare provider is required. The parent/guardian can determine if their child can safely self-administer a medication. However, controlled medications (i.e., narcotics and certain ADHD medication) as well as CBD oil are not permitted to be possessed by students and require a RAM. A separate RAM form should be completed for each medication, and the medication must be in its original packaging and not expired. If the prescribed medication, dose, or frequency changes prior to the start of school or during the school year, please submit an updated RAM. Please refer to the Student and Parent Handbook for additional information regarding medication administration.

SPECIAL CONSIDERATIONS

If your child has a seizure condition, the Medical Clearance for Students with Seizures and Waiver-Indemnification Form must be completed by parent/guardian(s) and your child's physician. A RAM form must be completed for any rescue medications that your child is prescribed.

If your child has a medical condition that may require emergency medication you will need to submit an action plan for each condition. Please contact your child's respective Health Room for these forms to have completed by your child's healthcare provider and upload to the EHR Parent Portal for review.

- **Complete requirements through the EHR Parent Portal by June 1, 2025.**

All New Invitees

- □ Complete the Health Summary.
- □ Complete the TB Screen.
- □ Upload a completed KS Physical Evaluation form with the date of the physical examination on or after July 1, 2024. The KS Physical Evaluation form must be used.
- □ Upload a current immunization record.
- □ If applicable, upload a completed Request for Administration of Medication (RAM) form for each medication that will be carried by the student or held on campus. This includes medication that will be held in the Health Room and administered by Health Services staff or designee. Controlled substances including common ADHD medications require a RAM.

Potential Student-Athletes

A physical examination is required at least every 13 months to be cleared for athletics.
